ADOPTION/PLACEMENT AGREEMENT

The Following Conditions and Regulations Apply:

1. **Ownership:** Circle F owns the horse until permanent placement has been arranged for.
2. **Shelter:** The horse(s) will be provided suitable shelter as outlined in the shelter/site guidelines.
3. **Use of horse:** The horse will be used for companion or pleasure riding purposes. The horse is not to be used for breeding unless otherwise stated. Neither the horse, nor any of its progeny can be used for racing. Limitations and exceptions are as follows:

*** During the adoption period the horse may not be sold, given away, or assigned***

4. **Transportation:** Transportation arrangements and costs are the adopter's responsibility.
5. **Required care:** The adopter is responsible for providing proper care and ongoing maintenance of the horse. This includes:
 - . Appropriate year round shelter
 - . Free access to clean water
 - . Proper feed
 - . Annual vaccinations and other vet care
 - . Regular farrier care
 - . Regular de-worming
 - . Exercise
6. **Notification:** Immediate notification shall be given to Circle F regarding the following:
 - . The necessity to have the horse put down supported by the adopter's vet.
 - . Serious injury or illness that could be life threatening supported by the adopter's vet.
7. **Right to visit:** The adopter agrees to have a representative of Circle F visit to see how things are going and address any questions that the adopter may have and, if changes are required, to discuss their implementation. The adopter may also call Circle F to have someone come for a visit.
8. **Insurance:** The adopter is responsible for liability and other insurance.
9. **Adoption fee:** The adoption fee for the above named horse shall be \$ _____ payable by cash or cheque/money order made out to **Circle F Horse Rescue**.

10. **The First Two Months:** It is expected that when a horse is adopted it is meant as an eventual permanent placement. However, questions regarding the care of the horse can be addressed with Circle F during this time. Should there arise a special circumstance, mutually agreed upon within this two month period, requiring the return of the horse, an administration fee of \$75.00 will be deducted and the remainder of the fee will be refunded. Two weeks notice must be given to allow Circle F to properly re-adopt the horse. After sixty days no refund will be given. Transportation costs are the responsibility of the adopter.
11. **Transfer of title:** Usually within the first 3-6 months of adoption the adopter will be able to retain title of the horse through a permanent placement agreement.
